He served as Premier of Ontario from 1990-1995, interim Leader of the Liberal Party of Canada from 2011-2013 and was appointed as Canada's Special Envoy to Myanmar (2017) and Canada's Special Envoy on Humanitarian and Refugee Issues (2020). From 1996 to 2008, he was a partner at Goodmans LLP and wrote government reports on the Air India bombing and higher

	education in Ontario. He also served as Chair of the Toronto Symphony Orchestra, the Royal Conservatory of Music, the Institute for Research in Public Policy and the Forum of Federations. Mr. Rae taught law and public policy at the University of Toronto and in the VicOne programme at Victoria College and was a partner and senior counsel to the law firm OKT LLP from 2014 to 2020, specializing in indigenous law and constitutional issues.
